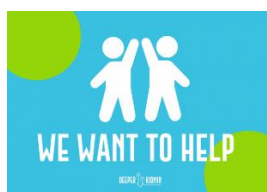


## Tenbury CE Primary Academy



### Helping and Supporting our Families

- **Early Years provision** from age 2 where appropriate
- **Home visits** for all of our Nursery and Reception pupils
- **Open door** approach to all of our parents/carers
- A daily **Breakfast Club** from 7.30am every morning to support parents/carers as and when needed
- Strong **communication** links between home and school
- **PSHE Curriculum**- Our school delivers comprehensive Personal, Social, Health and Economics and Relationship and Sex Education (RSE) programmes. These further support the children's understanding of how to keep themselves safe and healthy.
- **Online safety** – the school has a detailed Online Safety Policy which ensures all children regularly revisit E-safety training and activities in the curriculum during the school year. We work closely with our local police officer and CSO's to deliver workshops for our Y5/6 pupils linked to National Online safety Day every year and have run presentations to help parents develop a greater awareness of the dangers children may face online alongside strategies and tips to help keep them safe. A section of our school website is dedicated to E-safety with regular information for parents posted both here and on the weekly newsletter.
- **Anti-bullying** – our school is committed to tackling all forms of bullying and has clear Behaviour and Anti-bullying policies. Information on bullying and cyber-bullying are all part of the schools' PSHE curriculum and again, useful information and links can be found on our school website.
- **Attendance Matters!** The attendance of every child is carefully monitored and support offered where possible. The skills of the Education Welfare Officer are important in this role, carrying out home visits and attending meetings with parents/carers, in addition to sending letters home if attendance dips. We operate a first day response system and will always ring parents/carers the first morning a child is absent if we have not been contacted. We will also conduct first day absence home visits for our most vulnerable families.
- Effective links with the **Virtual School** in several different counties, supporting our Looked After Children
- **Tenbury Primary PTFA** – open to all of our families
- Strong links with **community social workers** and other support agencies, including Health Services, leading to **Multi-Agency Meetings** being held at school

- Support for families through the **Home Parenting Team Family Support Worker**. Through the **Starting Well** initiative, they are able to signpost parents and families to online courses/parenting groups and also offer targeted support when requested in the family home.
- **Team Teach** trained staff – positive behavioural support for all of our students
- Strong partnership links established with the **School Nurse and Health Visitor**
- Strong partnership links established with the **Speech and Language Therapy** team
- School regularly works with an **Educational Psychologist** who uses her knowledge of child development to assess difficulties children may be having with learning and offer recommendations and support to school and parents/carers
- **CAMHs CAST** – this is a professional body which is a service that sits within Worcestershire CAMHS (Child and Adolescent Mental Health Services). They work directly with young people experiencing or at risk of experiencing mental health difficulties. The service offers consultation, advice, support and training.
- **Reach 4 wellbeing** – this is an NHS service for face to face emotional support for pupils
- **Mentor Link** – this is a charity providing social and emotional support to young people where it is needed. Mentors will come into school and work 1-1 with our young people
- **PREVENT** trained staff- all of our staff team have received PREVENT training through our annual safeguarding training ensuring they are able to identify early stages of radicalisation and what to do. In addition, all teachers have completed the ‘Channel’ online training.
- **CSE** – the school uses the Child Sexual Exploitation Tool for early identification and makes referrals as necessary. Staff are trained to identify early indicators of potential cases of child sexual exploitation.
- **FGM** – all staff have received training on Female Genital Mutilation and teachers know how to identify if a child may be at risk. They know the signs to look for and most importantly how to refer, following the school’s safeguarding procedures.
- **Operation Encompass** – our school is notified the following day if there has been a domestic abuse incident which may affect one of our pupils, so that we can provide the support which may be needed when they get to school.
- **Mental Health support** – this can be provided for pupils by Mrs Phelps, a trained Mental health First Aider in school, who can also signpost families to other services.
- **The Nurture Approach is used in school** – using the ‘**Boxall Profile**’ we are able to identify potential social, emotional, behavioural and/or mental health concerns as early as possible and then use nurturing interventions to support children to develop their social and emotional skills.

<p>Home-school support</p> <p>Worcestershire Home Education Network</p>	<p>Home education is becoming an increasingly popular option for families in Worcestershire and we have a growing community that are able to offer each other support. Between us we have years of experience in educating children of all ages and are able to organise and put on a range of activities.</p> <p>We hold meetings usually at least weekly, throughout term time at various locations round the county-for example:</p> <ul style="list-style-type: none"> <li>- <i>Social gatherings occur monthly in North Worcestershire for all ages, with both indoor and outdoor games plus organised activities such as climbing/zip-wires/grass sledging for 8+.</i></li> <li>- <i>Monthly meeting in Worcester with games, music and crafts for all ages.</i></li> <li>- <i>Monthly social meeting in south Worcestershire, including indoor and outdoor games, group music session and a drama group.</i></li> <li>- <i>Bowling or Ice skating most months.</i></li> <li>- <i>"Education group" workshops organised regularly. Recent workshops have included: Marvellous Mosaics' 'Gunpowder plot' 'Medieval life', 'Making Music' and 'Creative Writing.</i></li> </ul> <p>We also meet up with people from neighbouring counties and many of us go along to the national camps and gatherings that are organised by home educators throughout the year.</p> <p>We have a Worcestershire Home Educators Newsletter (WHEN) that lists all of the activities for the coming month and run a Worcestershire Home Educators Internet support list.</p>

<p>Bullying (including cyberbullying)/ Child death/suicide/prevention</p>	<p><b>Cyberbullying</b> is using the internet, email, online games or any digital technology to threaten, tease, upset or humiliate someone else.</p> <p>If the police consider a message or post to be potentially criminal, they will take appropriate action. This could involve arresting the person responsible or interviewing them under caution. Cases involving sustained abuse or where someone’s life is threatened will be treated seriously. The police will consider all of the circumstances when considering the best response to a report of cyber bullying. They will assess how vulnerable the victim is and what resources are required to trace the offender via social networking sites that often operate abroad and to different legislation. In certain cases it may be difficult to take action if the offender isn’t in the UK. They will work with the victim to bring about the most suitable and proportionate conclusion, this will include alternative options that include the officer in the case using their discretion and working with the offender to record an apology to the victim.</p> <p><b>Useful links</b></p>

Hate Crime	<p>A hate crime is a criminal offense whose motivation can be shown to be race, national origin, religion or sexual orientation. A difference of race alone is NOT sufficient to make it a hate crime. of their disability, where the disability has a profound impact on the child or young person's life.

An assessment will be offered where the child has a condition which is substantial, long lasting or permanent, is a physical and/or learning disability or a life limiting, life threatening condition. These may include:

- severe learning disabilities
- severe physical disabilities
- severe developmental delay in motor and or cognitive functioning
- profound multiple disabilities
- severe sensory impairment (registered blind and/or profoundly deaf)
- complex and severe health problems that arise from the disability, that are life threatening, degenerative illness or organic disorder resulting in severe disability
- a diagnosis of Autistic Spectrum Condition with an associated learning disability and where the condition severely affects day to day functioning

<p>Early Help</p>	<p>Early help guidance for professionals</p> <p>What is early help?</p> <p>Early help means providing support as soon as a problem appears, to stop it from getting worse. This could be at any point in a child's life, from birth to the teenage years.</p> <p>Anyone can provide early help – you don't need to be an expert professional. Early help is not about passing the issue on to an expert, but thinking about what is the best support you can offer.</p> <p>You can provide effective support by:</p> <ul style="list-style-type: none"> <li>• listening</li> <li>• working with other people who could help</li> <li>• finding out about specialist agencies who could help</li> <li>• filling out an <a href="#">Early Help Assessment</a> with the person you are helping</li> <li>• contacting <a href="#">Children's Social Care</a> if you think the problem is more serious</li> </ul> <p>There is a lot of information and advice on the <a href="#">Advice, Care, Health and Support pages</a> as well as detail of local services that can provide support for children, young people and families.</p> <p>Download: <a href="#">Worcestershire Special Educational Needs and Disabilities (SEND) strategy</a></p>
<p>DDNs (Dangerous Drug Networks)</p>	<p>DDN's are drug dealing gangs who target vulnerable people in order to set up drugs distribution networks.</p> <p>These criminals are using extreme violence to establish a presence, displacing an existing drug supply chain and intimidating rivals, witnesses and victims, this has resulted in local murders.</p>

<p>Child Sexual Exploitation (CSE)</p>	<p>West Midlands Safeguarding Children Procedures has a page dedicated to <a href="#">Child Sexual Exploitation</a>. It provides information about child sexual exploitation, the roles and responsibilities of relevant agencies and the procedures practitioners should follow to ensure the safety and well-being of children and young people whom it is suspected have been sexually exploited or are at risk of sexual exploitation.</p> <p><b>Key facts about CSE</b></p> <ul style="list-style-type: none"> <li>• It affects both girls and boys and can happen in all communities.</li> </ul>

- Any young person can be targeted but there are some particularly vulnerable groups: Looked After Children, Children Leaving Care and Children with Disabilities.
- Victims of CSE may also be trafficked (locally, nationally and internationally).
- Over 70% of adults involved in prostitution were sexually exploited as children or teenagers.
- Sexual violence or abuse against children represents a major public health and social welfare problem within UK society, affecting 16% of children under 16. That is approximately 2 million children.

<p>Fabricated and induced illness (FII)</p>	<p>Fabricated or induced illness (FII) is a rare form of child abuse. <p>Faith abuse</p>	<p>Faith and belief-based child abuse, including practices around ‘spirit possession’ and ‘witchcraft’, is a hidden crime, which makes it difficult to quantify in terms of magnitude. <p>Honour based violence (HBV)</p>	<p>Honour' based violence (HBV) occurs when perpetrators believe a relative or other individual has shamed or damaged a family's or community's 'honour' or reputation (known in some communities as izzat), and that the only way to redeem the damaged 'honour' is to punish and/or kill the individual. 'Honour' based violence is a term that is widely used to describe this sort of abuse however it is often referred to as <b>so called 'honour' based violence</b> because the concept of 'honour' is used by perpetrators to make excuses for their abuse. There is a very strong link between 'honour' based violence, forced marriage and domestic abuse. The term 'Honour Based Violence' is the internationally recognised term describing cultural justifications for violence and abuse. Honour Based Violence cuts across all cultures and communities: Turkish, Kurdish, Afghani, South Asian, African, Middle Eastern, South and Eastern European for example. This is not an exhaustive list. Where a culture is heavily male dominated, HBV may exist. The police have made it a high priority to help communities fight back to tackle</p>

In some cases, missing adults may have made a choice to leave and ‘start their lives over again’, but the vast majority of missing people, children and adults, are vulnerable and need protection and support. The strategy has three key objectives which provide the right foundations for any effective local strategy to tackle this issue: Prevention - reducing the number of people who go missing, including through prevention strategies, education work and early intervention in cases where children and adults repeatedly go missing Protection - reducing the harm to those who go missing, including through a tailored, risk-based response and ensuring agencies work together to find and close cases as quickly as possible at a local and national level Provision - providing support and advice to missing persons and families by referring them to agencies promptly and ensuring they understand how and where to access help.
